Effectiveness of an information booklet on knowledge regarding behavioral problems of school children among primary school teachers

Abstract

Background: A behavioral problem is a departure from normal (acceptable) behavior beyond a point, to the extent behavioral problems can manifest themselves in many ways. There are interchangeable terms for behavior disorders- disruptive behavior disorder, conduct disorders, emotional disorders, and emotional disturbances.

Methodology: A quantitative approach with pre experimental one group pretest posttest design was adopted for the study. The samples from the selected from primary schools of Vijayapura district by using non probability purposive sampling technique. The samples of present study comprises of 60 primary school teachers. The tools used for data collection was structured knowledge questionnaire.

Results: With regard to pretest level of knowledge it shows that, maximum 40 (66.7%) respondents were having average knowledge, 16 (26.7%) respondents were having good knowledge and remaining 4 (6.7%) of respondents were having poor knowledge and during post-test maximum 48 (80%) of respondents were having average knowledge and 12 (20%) of respondents were had good knowledge. The statistical paired 't' implies that the difference in the pretest and post-test value was found statistically significant at 5% level ($p < 0.05$) with a paired value of 13.15. There exists a statistical significance in the difference of knowledge score indicating the positive impact of information booklet.

Conclusion: The primary school teachers were had moderate level of knowledge in pretest and is improved after undergoing intervention. School teachers should be equipped with adequate knowledge for finding the behavioral problems among children at the early stage and give proper attention to them.

Introduction

School age is the period between 6-12 years. Scholars are emerging as creative persons who are preparing for their future role in society. The school years are a time of new achievement and new experiences. Children's individual needs and preferences should be respected. Children who is productive and engaged in the school experience, whether academic or vocational, is not likely to become at - risk student [1].

All young children can be naughty, defiant and impulsive from time to time, which is perfectly normal. However, some children have extremely difficult and challenging behaviors that are outside the norm for their age [2]. The behavior of some children and adolescent are hard to change. Children do not always display their reactions to events immediately although they may emerge later. Children who suffer from behavior disorders are at a higher risk for school failure, suicide, and mental health problems [3].

A behavioral problem is a departure from normal (acceptable) behavior beyond a point, to the extent behavioral problems can manifest themselves in many ways. There are interchangeable terms for behavior disorders- disruptive behavior disorder, conduct disorders, emotional disorders, and emotional disturbances [4].

School plays a crucial and formative role in the spheres of cognitive, language, emotional, social and moral development of children. There is now a growing recognition that schools have a significant role in promoting mental health. Teachers are powerful groups who have in their process of education studied the nature of individual growth. This has equipped them to be in a position to shape and reshape behaviors that are warranted. Nearly one in five children and adolescents will have emotional and behavioral disorders at some times in their youth. Mental disorders in schools amount to 3.12% in students. Even by conservative

Estimates 10% of the child population suffers from mental disturbances with serious associated impairments including learning problems, health problems and during abuse any given time. At least 3% of school age children suffer from serious emotional disturbances at any given point of time [5]. The quality of childhood life solely depends on the type of environment. School and neighborhood unhealthy social surroundings can put them at stress and can increase their vulnerability to develop emotional disorders. As children are easily amenable to different stresses and strain, it is imperative on the part of parent and teachers to know the intricacies of a healthy psychosocial environment leading to behavioral patterns which are personally satisfying and socially acceptable [6].

Disruptive behavior students are in every classroom across the nation. Teachers are constantly searching for assistance, guidance, ideas, suggestions and relief from this challenge. Yet teachers must remember that they are the source of hope for many of these children and the person who plays a most important role in their lives.

The school is an educational institution where groups of pupils pursue defined studies at defined levels; receive instructions from one or more teachers. The school health service is one of the aspects of community health nursing, it refers to providing need based comprehensive services to pupils to promote and protect their health, control diseases and maintain their health [7].

In the light of the above mentioned studies the investigator observed that the prevalence rate of psychiatric disorder in India is more in middle class children and the knowledge of teachers regarding behavioral disorder is not done in the child age then they may go for antisocial personality disorder. So the investigator took up this study for primary school teachers so that it helps in early identification of behavioral problems among school children.

Objectives

1. To assess the knowledge of primary school teachers regarding Behavioral problems of school children in terms of pre-test knowledge scores.
2. To evaluate the effectiveness of information booklet on knowledge of primary school teachers regarding behavioral problems of school children by comparing pre-test and post-test knowledge scores.
3. To find the association between the pre-test knowledge scores of primary school teachers regarding behavioral problems of school children and selected demographic variables.

Hypothesis

H₁: The mean posttest knowledge scores of primary school teachers regarding behavioral problems of school children, who have undergone the information booklet, will be significantly higher than their mean pre-test knowledge scores.

H₂: The levels of knowledge of primary school teachers regarding behavioral problems of school children will be significantly associated with their selected personal variables.

Methodology

Research approach

A quantitative research approach.

Research design

Pre experimental one group pretest posttest design.

Study setting

Primary schools of Vijayapura district, Karnataka.

Population

Primary school teachers.

Sampling Technique

Non probability purposive sampling

Sample Size: 60

Source of Data Collection

Primary and secondary data will be collected from the school teachers of selected primary schools.

Method of Data Collection

Self-report.

Tools of data collection

The tool for data collection was divided into 2 parts which consists of demographic data and structured knowledge questionnaire

Part I: Demographic data

It consists of 7 items related to demographic data which includes age, gender, religion, educational status, class handled by the teacher, years of experience, residential area, source of information regarding specific behavioral problems.

Part II: Structured knowledge questionnaire

This section consists of 30 structured multiple choice items with the four options for each item to assess the knowledge of school teachers regarding behavioral problems among school children. The participant has to choose one right answer from given options. The right answer will be scored as 'one' mark and the wrong answer will be scored as 'zero' comprising the maximum score of 30. The total score is arbitrarily divided as Poor Knowledge (0-10), Moderate Knowledge (11-20), and good Knowledge (21-30).

Procedure of data collection

After obtaining permission from concerned authority of selected primary school, Vijayapura and consent from subjects the pre-test was conducted to 60 participants using structured knowledge scales; approximately 45 minutes were spent for collecting data. The investigator gathered participants in a comfortable room and conducted Pre-Test in selected primary School. Soon after the test, the information booklet was administered. On 8th day post-test was given with the same structured knowledge scale and took about 45 minutes to complete the post-test.

Results

Table 2: reveals pretest knowledge score of respondents regarding behavioral problems among primary school children, it shows that.

The pretest knowledge scores respondents mean was 12.14, median was 12, mode was 12 with standard deviation 4.16 and score range was 6-24.

The posttest knowledge scores respondents mean was 15.98, median was 15, mode was 12 with standard deviation 3.80 and score range was 11-25.

The data presented in the Table 3 depicts the, with regard to pretest level of knowledge it shows that, maximum 40(66.7%) respondents were having average knowledge, 16(26.7%) respondents were having good knowledge and

remaining 4(6.7%) of respondents were having poor knowledge. During post-test maximum 48(80%) of respondents were having average knowledge and 12(20%) of respondents were had good knowledge.

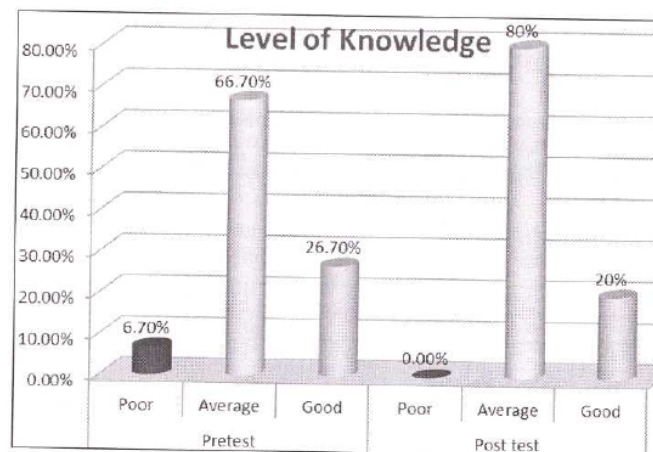


Fig 1: Pretest and posttest level of knowledge

Table 4: indicates the overall mean knowledge scores of pre-test and post-test scores.

The statistical paired implies that the difference in the pretest and post-test value was found statistically significant at 5% level ($p < 0.05$) with a paired 't' value of 13.15. There exists a statistical significance in the difference of knowledge score indicating the positive impact of information booklet.

Hence, the research hypothesis H_1 is supported. This indicates that the enhancement in knowledge is not by chance and the primary school teachers who exposed to information booklet on behavioral problems among primary school children, significantly improved in their knowledge.

Association between level of knowledge and selected socio demographic variables

The computed Chi-square value for association between level of knowledge of primary school teachers regarding behavioral problems in children is found to be statistically significant at 0.05 levels only for source of information and is not found significant at 0.05 level for age, gender, religion, educational status, years of experience, and residential area.

Conclusion

The conclusions drawn from the study were as follows

1. The overall pretest knowledge of primary school teachers regarding behavioral problems among children was average and favorable respectively.
2. There was a need for information booklet regarding behavioral problems among children
3. Post test results showed significant improvement in the level of knowledge of primary school teachers regarding behavioral problems among children. Thus, it can be concluded that information booklet was effective to increase and update their knowledge on behavioral problems among children.

4. The results revealed that there is partial association between pre-test knowledge scores and teachers sources of information.

To Assess the Effectiveness of Foot Massage on Pain among Post Abdominal Surgery Patients in Selected Hospital

ABSTRACT

Background: Post-operative pain can have a profound effect on patient recovery. An understanding of patient attitudes and concerns about post-operative pain is important for identifying ways health care professional can improve postoperative care. Although pain is a predictable part of the post-operative experience, inappropriate management of pain is common and can have profound implications. Unrelieved postoperative pain may result in clinical and psychological changes that increase morbidity and mortality as well as costs and the decreased quality of life.

Objectives of the study: To assess the existing level of pain in experimental and control group among post abdominal surgery patients. To evaluate the effectiveness of foot massage on post abdominal surgery pain by use of numerical pain scale. To find out association between pre-test pain scores and demographic variables.

Method: Conceptual framework of the study was based on Modified system of Lydia Hall's care model. The study was conducted using Pre-Experimental One group pre-test post-test on a sample of 40 post abdominal surgery patients selected by purposive sampling technique admitted in surgical intensive care units

Result: The Wilcoxon signed ranks test Z value significantly decreased during the post test on day 1 day 2 and day 3 when compared to the pre test values. Thus the intervention of foot massage was effective in decreasing the pain intensity of the post abdominal surgery patients at 0.01 level of significance thus H_1 was accepted.

Conclusion: The result of the study demonstrated that the foot massage has reduced the pain; thereby foot massage was effective on pain among on abdominal surgery patients.

Keywords-- Foot massage, pain, post abdominal surgery patients.

INTRODUCTION

Pain is a phenomenon that is very difficult to define; it is more subjective & personal. There are no objective measurements so it is nurse's duty to help patients to overcome pain & make them comfortable Pain is a signal from ailing tissues to indicate that there is something wrong. It is difficult to describe pain, because everyone reacts so differently to it. Each person's reaction varies; pain must be measured indirectly, based upon information offered by the pain sufferers. Today pain has become a universal disorder, a serious & public health issue & a challenge for healthcare providers. The degree of post operative pain depends on the site of the surgery. Surgery on the thorax and upper abdominal region are usually more painful. Chronic pain reduces physical activity and leads to venous stasis and an increased risk of deep vein thrombosis and urinary tract infection. Post operative pain is a routine poorly controlled by pharmacological means alone. Complementary strategies are needed to aid in postoperative pain relief as patients routinely report mild to moderate pain even though pain medications have been administered. Postoperative outcomes such as severe pain, anxiety, psychological distress and sleep disturbance are commonly

associated with recovery from abdominal surgeries. These factors may compromise the effect of their treatment and quality of life of patients undergoing major abdominal surgeries. Pain can prolong a patient's stay in the hospital and affects their satisfaction level.

STATEMENT OF PROBLEM

"A study to assess the effectiveness of foot massage on pain among post abdominal surgery patients in selected hospital."

OBJECTIVES OF THE STUDY

1. To assess the existing level of pain in experimental and control group among post abdominal surgery patients.
2. To evaluate the effectiveness of foot massage on post abdominal surgery pain by use of numerical pain scale.
3. To find out association between pre-test pain scores and demographic variables.

HYPOTHESIS

H0: There will be no significant difference in the intensity of pain among post abdominal surgery patients after implementation of foot massage.

H1: There will be significant difference in the intensity of pain among post abdominal surgery patients after implementation of foot massage.

H2: There will be a significant association between intensity of pain and selected demographic variables.

METHODOLOGY

Research Approach: Quantitative Evaluative approach

Research Design: Pre Experimental One group pre-test post-test design was used

Setting of the Study: The setting of the present study was surgical ICU's of selected hospitals

Population: All patients who have undergone abdominal surgery

Sample Size: 40 post abdominal surgery patients

Sampling Technique: purposive sampling technique was used.

VARIABLES UNDER THE STUDY

Dependant Variable: Pain among post abdominal surgery patients

Independent Variable: Foot massage

Inclusion Criteria

1. Patients who are conscious and willing to participate in this study.
2. Patient who are available at the time of the study.
3. Patients who have undergone abdominal surgeries.

Exclusion Criteria

1. Patients who are on ventilator support
2. Patient who have foot related problems like contractures, deformities and previous surgical interventions

Tool

The tool used for gathering the data was Universal Numerical pain rating scale

Plan for Data Analysis

The data obtained was analyzed using both descriptive and inferential statistics based on objectives and hypothesis of the study. Experts in the field of nursing and statistics directed the development of data analysis plan which was as follows:

1. Organizing data on master sheet
2. Tabulation of the data in terms of frequencies, percentage, mean, standard deviation to describe the data
3. Classifying The numerical rating scale to the individual pain tolerance, the user has the option to verbally rate their scale from 0-10
 - a. 0 indicates the absence of pain.
 - b. 1-3 indicated mild pain
 - c. 4-6 indicated moderate pain
 - d. 7-10 indicated severe pain

The data presented in table 1 depicts that majority of post abdominal surgery patients 21(52.5%) were female and 19 (47.5%) were males. 27. Equal number of patients i.e. 12 (30%) belonged to the age group of 31-40 and 41-50 years and only 5 (12.5%) patients belonged to the age group of 51 and above. Majority of the subjects 13 (32,

4%) possessed primary education, while only 4 (10%) patients were graduate education. Majority of the patients had occupation that came under the category of moderate work i.e. 21 (52.5%) belonged while 15 (37.5%) patients were heavy workers and only a minimum of 4 (10 %) were sedentary

Table 2 reveals that level of intensity of pain in the experimental and control group on day 1, day 2 and day 3. On day 1 the pre mean was 8.75 (0.444) and when it was compared with day 1 the post mean was 7.95 (0.51) and the evening pre-mean was 7.55 which was markedly decrease to 6.9(0.718). On day 2, the pre mean was 6.45(0.51) and post mean was 5.65(0.745) and in the evening

the pre mean was 5.25(0.444) and post mean was 4.7 (0.733.) While on day 3 the pre mean was 4.2(0.61.) and post mean was 3.55(0.826) and the evening pre mean was 3.15(0.671) and the post mean was 2.6 (0.681).

This shows there is significant decrease in the level of pain intensity among the post abdominal surgery patients among the experimental group (at p 0.5 level).

Table 5 reveals that the association between the pretest intensity of pain and demographic variable: age and gender are independent of each other. There is no statistically significant association between pre score and socio-demographic characters thus **H2** was rejected

DISCUSSION

The findings of the study are discussed under the following headings:

- Findings related to the pain in the post abdominal surgery patients.
- Findings on association between pre-test score and demographic variables

1. Findings related to the pain in the post abdominal surgery patients.

The level of pain intensity of post abdominal surgery patients was assessed in pretest. The result showed that majority 40 (100%) patients had severe intensity of pain, whereas in post-test that is after the foot massage intervention the intensity level of pain was decreased to a significant level among the experimental group. Similar findings were seen in a study conducted Iran the experimental group received pressure on a defined area of the right foot for about 10 minutes. Patients in the control group received routine care only. The results showed there was a notable difference in pain intensity between the intervention and other groups after the intervention.

2. Findings on association between pre-test score and demographic variables

Pre-test score and demographic variables were assessed and analysis was done using Fisher's test was done. There was no association found

between the pre- test score and the demographic variables age, and sex. Contrast findings were seen in a study conducted Y. Berhe the result also showed that there was significant association between the demographic variable and pre test intensity level of pain.

IMPLICATION OF THE STUDY Nursing Practice

Nurse is the key person to deliver a qualitative care to the patients, and it is the key function of a nurse to protect the patient from pain and sufferings. The research findings suggest that the foot massage will improve the pain among post abdominal surgery patients. Nurses can administer Foot massage exercise for patients undergoing post abdominal surgery.

Nursing Education

The health care delivery system at present is giving more emphasis on preventive aspects and health promotion. Nursing curriculum should give more emphasis on complementary Foot massage exercises to reduce pain among post abdominal surgery.

Nursing Administration

The administrator should be able to motivate and initiate the health personal in organizing, conducting and participating in various educational programmes that would improve the knowledge regarding 'Foot massage techniques' in post abdominal surgeries. The administrator can also work as a

resource person for other nurses, students, clients and relatives.

Nursing Research

The nurse research can utilize the study findings in developing model/theory/conceptual framework/amendments. Based on the findings of the further study the future research can be undertaken. The study findings can help to expand the scientific body of knowledge.

CONCLUSION

Based on the analysis of the findings of the study, the following inference was drawn. That there is decreased level of intensity in pain among post abdominal surgery patients. The study suggests that there is a need to stress on the pain is a predictable part of the post-operative experience; inadequate management of pain is common and can have profound implications. Unrelieved postoperative pain may result in clinical and psychological changes that increase morbidity and mortality as well as costs and the decreased quality of life.

Most human beings, accustomed to the traditional methods but it should be accustomed with adjuvant methods as well to provide good and comprehensive care to the patients. Thus foot massage is one such measure that is used to alleviate the pain intensity.

LIMITATIONS

Few limitations faced while doing the study:

1. The study was confined only to a small sample size of 40 post abdominal surgery patients thus the result of the study cannot be generalized

2. The study was confined only to the educated population.
3. The study was limited to evaluating the effectiveness of foot massage only.
